The topic of my thesis was: "The Persistence of Poverty in Post-Apartheid South Africa: Assets, Livelihoods and Differentiation in KwaZulu-Natal, 1993-2004". The analysis is based on a panel data set collected in 1993, 1998 and again in 2004. Econometric methods are used to develop an asset-based poverty line and to examine household livelihood strategies, asset accumulation and the link between these strategies and the persistence of poverty in South Africa.

August, 1997 to Present, Senior Research Fellow, Associate Professor and Full Professor (2008), School of Development Studies, University of KwaZulu-Natal.

This post involves both research and post-graduate teaching activities. My research is principally focused on dynamics of poverty, the linkages between poverty and population and programmes for poverty reduction. I have taught post-graduate courses in Research Design, Poverty and Inequality, Economics for Development and Population and Development and have completed the supervision of 20 Masters dissertations and 2 PhD theses, and am currently supervising 1 Masters dissertation and 2 PhD theses. Eighteen of these students are from previously disadvantaged groups and 20 are women. I have examined 20 Masters dissertations and 4 PhD theses. I have given short courses in poverty measurement and monitoring to government and NGO officials from Lesotho, Maldives, Mozambique, Namibia, Swaziland, Sweden and Zimbabwe. I have served on the Faculty Research Committee and chaired a task team investigating a new policy for overheads recovery at the merged University of KwaZulu-Natal. I have been/am the principal investigator for the following larger research projects:

- **2007-2009: Living Conditions Survey:** This survey is a new component of the South African national statistics system and gathers data from 30 000 households. A range of outcome variables are considered including household consumption gathered through a diary method, anthropometric data and subjective poverty indicators. I am the lead consultant to Statistics South Africa on this project.
- **2007-2010:** Community-based Learning, ICT and Quality-of –life (CLIQ): This study useds a combination of Participatory and Action-Based methodologies to assess the impact of an ICT intervention on poorly resourced communities in KwaZulu-Natal. The project is funded by the National Research Foundation and the Norwegian Research Council and is being undertaken in collaboration with the Universal Service and Access Agency of South Africa (USAASA).

- county, analysis was undertaken on existing quantitative data, while additional qualitative information was collected. The study was funded by the MacArthur Foundation
- 1998-2010: Monitoring the land reform programme in South Africa. This 10 year panel study is collecting data from 2000 land reform beneficiaries in South Africa. The objective is an ongoing assessment of the quality of life of participating households, the economic viability of the livelihoods and enterprises that are established, and the targeting performance of the programme. The Department of Land Affairs and more recently, the World Bank and Norwegian Research Council/NRF have funded this research. The project is a collaborative study involving the National Department of Land Affairs, the University of Cape Town, the World Bank and the Norwegian Institute of Urban and Regional Studies.
- **1999 –2000: Evaluating the Global Poverty Strategy Initiative**: A comparative assessment of poverty measurement. This study was commissioned by the UNDP, and involved a review of 15 country studies with field research in Uganda, Zambia, the Maldives and Lesotho.
