Research and Teaching Roundup

## World Health Organisation Study

One of Dr Pranitha Maharaj's current projects, funded by the World Health Organisation, explores the dynamics of condom negotiation and use in marital relationships. Building on a previous study conducted in 1999, the project examines pathways to adopting condom use in stable relationships. It considers individual, couple, and community level characteristics and condom use, and integrates a population-based quantitative survey with qualitative in-depth interviews to better document condom use and its determinants in different settings and to shed light on strategies effective for behaviour change. The first phase involving household surveys has been completed. The second phase of the study, involving in-depth interviews, will commence shortly. Joanna Busza from the London School of Hygiene and Tropical Medicine has been involved in training the field workers for the in-depth interviews.

## Water Institutions and Delivery - Case Studies

Glen Robbins recently completed two water and sanitation services case studies on the llembe district and on uThukela Water (Pty) Ltd for Water Dialogues South Africa. The studies both demonstrated the considerable institutional complexities of water and sanitation service arrangements in less capacitated regions, and the impacts these have on delivery. The uThukela Water report was prepared with research reports from four School of Development Studies Masters students: Ariel Bright, Cyriaque Hakizimana, Welcome Mwelase and Tasmi Quazi.

#### Population Association of South Africa (PASA) Conference

The School of Development Studies was academic host to the Third Annual Population Association of Southern Africa Conference which took place recently in Durban. The theme was *Demographic Challenges in Southern Africa: Context and Change*. Thirteen of our students attended the conference, and several presented papers. Two Population Studies students, Mr P T Letsoalo and Ms T Magagula, were awarded first and second prize for the best student paper at the conference. Congratulations go to Ms Chantal Munthree, Coordinator of the APSTAR Programme in the School, who was elected PASA Secretary for 2009.

#### Student/Staff Exchange Programme

As part of a Linnaues-Palme Exchange Programme and European Mundus Scholarship, the School of Development Studies enjoys an annual exchange of students and teachers with Sweden's Linköping University. The programme has enabled the School's Masters students to attend courses at Linköping University and likewise, for Linköping's Masters students to attend modules at the University of KwaZulu-Natal. Earlier this year, Dr Pranitha Maharaj attended a workshop at Linköping to plan further collaboration with Swedish researchers using a grant funded by the National Research Foundation. As part of the exchange, the School is currently hosting Dr Annette Wickström who presented a seminar on 'Virginity Testing as a Local Public Health Initiative'.
